### FACTS PAYMENT PLANS AVAILABLE: One plan/one-time fee per family

## ADDITIONAL DISCOUNTS:

Pastors' Children: Full Time or Bi-vocational	Pastors: 50% discount, per child. Other Ministerial Workers (i.e. youth pastors, music ministers etc.): 25% tuition discount, per child. *Not applicable for Charter Members. *Not applicable to fees. *A letter on church letterhead certifying employment of 30 hours a week or more in a pastoral/ministerial position must be presented at the time of registration to qualify. <b><u>No other discounts apply</u></b>
Multiple Children:	2 <sup>nd</sup> sibling student and on will receive a 10% discount off their tuition amount starting with the oldest student enrolled. Not applicable for Charter Members or students with scholarships.
Qualified Employees Children:	50% off of regular tuition rates & 25% off of regular tuition rates for part time teachers (working at least 20 hours per week). *Not applicable to fees.
Charter Membership:	<ul style="list-style-type: none"> <li>• First 100 registered students only, unless class is full</li> <li>• Lock in your student's tuition rate at the current tuition rate of the grade level to enter FOECA (minimum amount of the grade school rate)</li> <li>• Guaranteed FIRST CHANCE PLACEMENT</li> <li>• <b><u>No other discounts apply</u></b></li> </ul>

### Explanation of Fees:

Registration Fee:	This fee is paid when the decision has been made to finalize enrollment. This fee is not refundable and due at registration.
Charter Fee:	This fee is paid when the decision has been made to enroll in the optional Charter Program. This fee is not refundable and due at registration.
Testing Fee:	New students may be required to take a placement test prior to enrollment. Results of this test will be included in the decision making process. This fee is not refundable.
Materials Fee:	Purchase and maintenance of textbooks, planners, workbooks, duplication costs, library, supplemental materials etc. This fee is not refundable and due by enrollment.
FACTS Fee:	This is a nonrefundable Payment Plan fee collected by FACTS to administer the payment programs. This fee is paid <u>once per family</u> . Annual payments have no fee required. <b>There is a \$50 deduction off those fees for those paying with Automatic Bank Withdrawal!</b>
ACSI/ISAT Fee:	This is a non-refundable fee that covers our association with ACSI including all standardized testing materials. It only applies to students receiving scholarships.
TRP Fee:	This is a nonrefundable fee charged by TRP (ANG Dewar) to ensure your obligation for a full years tuition is fulfilled ~ even for early withdrawal. This nominal fee is paid once per child/family.
Other Fees:	See FOECA Yearly Fees Form
