3 & 4 Year-Old Pre-School

Children enrolled in Families of Faith Christian Preschool learn in a safe and nurturing environment where Godly character is promoted and the wholeness of every child is addressed. As children absorb ideals early, we feel strongly that a values-driven environment is essential during the early education process and beyond. FOFCA sets the stage for self-confidence and inspires educational and social success.

We are committed to high academic standards and that commitment starts with our Pre-School program. Small class sizes and committed teachers create the ideal atmosphere for early childhood learning and preparing students to excel in kindergarten and beyond. Children in our Preschool program are imaginatively exposed to academic concepts in language, math, and science, as well as motor, social and life skills that they will later master in kindergarten.

There are some requirements for a child to enter into our preschool program:

- Child must be 3 or 4 years old by September 1st to enter the 3 or 4 yr. old preschool program.
- I understand that a registration fee of \$250.00 (\$150 if re-enrolling) is required with the enrollment application.
- I understand that there is a \$180.00 book fee for one session or \$250 for two.
- I understand my child must be potty trained and will not be allowed to wear diapers or pull-ups to school.
- I understand that if my child misses a day of preschool, there will no make-up day, nor will a refund be issued for that day. Our preschool must not be mistaken for a daycare, it is a learning environment that has the same standards as any other school.
- I understand that children are accepted in good faith. Occasionally, however, it is necessary to remove a child from the program. The Administration reserves the right to dismiss a child, if after a conference with the parents, they determine that it is in the best interest of the child and FOFCA.
- I understand that I must keep a full change of clothes, for my child, at the school always.
- I understand that I must follow the guidelines of FOFCA enrollment and tuition procedures.
- I have read and understand the FOFCA Preschool Handbook.
